Invitation to Dialogue

One of our members, Edward Geary, the book review editor for <u>Dialogue</u>, invites CMSC members to suggest to him books to be reviewed as well as possible reviewers. He desires three types of reviews: 1.) brief informative notes (under 250 words); 2) analytical reviews of

individual books (50-1500 words); and 3) longer review essays which explore the issues raised by either a single important book or a group of related books. Geary is especially interested in suggestions for books to be reviewed which can be handled from a Mormon point of view even though not published primarily for a Mormon audience.

"Economics and the Mormon Culture"

CMSC member J. Kenneth Davies has sent an invitation to us which all our members will find of interest. The Department of Economics at BYU, as part of the university's centennial year, will sponsor a conference on the general theme "Economics and the Mormon Culture." It will take place Oct. 6-8, 1975, on the Provo campus. Expressions of interest in participating are now being solicited and may be addressed to Davies. Not only economists but other interested participants are welcome. There will apparently be some funds with which to subsidize travel expenses of those giving papers, and an issue of <u>BYU Studies</u> will be devoted to some of the best papers.

The illustrative topics offered include the following major headings:

- 1. Mormon Economic History
- 2. Mormon Economic Thought
- 3. Economics of the Mormon Family
- 4. Theories of Church Economic Behavior
- 5. Mormons in Less Developed Societies
- 6. Mormons and the American Culture

The sub-topics indicate that "economic" is being construed rather broadly. Copies of a tentative list of LDS economists (numbering 260) can be obtained, along with the list of topics and a form for expressing the nature of your interest, from the organizer at 304 JKB, BYU.

Mormon Scientists and Scholars

Kenneth R. Hardy, one of our number, recently published an extremely important article: "Social Origins of American Scientists and Scholars," Science, Vol. 185, 9 August 1974, pp. 497-506. The piece especially considers the religious background of scientists and scholars. The Latter-day Saints are prominently mentioned. Hardy has data showing some changes in the rate of production of such experts over time. Not only the data, but the analysis, is significant. The author offers a reprint to CMSC people who send a request to him (1234-B SFLC, BYU).

Journal of Mormon History Published

If you are a member of the Mormon History Association, you already have received this journal. The first issue includes an article on "Mormonism's Encounter with Spiritualism" by Davis Bitton, of the CMSC Executive Committee, as well as a significant work by Michael Quinn, "The Evolution of the Presiding Quorums of the LDS Church." The latter, along with

Duane Jeffrey's article in <u>Dialogue</u> on the development of LDS thought on evolution and Gordon Irving's "The Law of Adoption" in the Spring 1974 BYU Studies gives impetus to interpreting LDS thought in the context of changing society which many of us will profit from.

Nibley Volume Underway

Jack Welch of CMSC (2222 Strebor Rd., Durham, NC 27705) is the moving force behind preparation of a volume of essays contributed by students and friends of Professor Hugh Nibley. Those wishing further information can inquire directly to Welch.

Family History Conference?

G. Wesley Johnson (History Department, University of California-SB, Santa Barbara, CA 93107) is considering conducting a conference next year at BYU on family history. If you have a contribution or wish to attend, you could write to him. He taught a very successful course in the subject last summer in Provo.

No Third Conference on Mormon Language?

Harold Madsen and John Sorenson, who organized conferences on Mormon language the last two years, have decided that there is too little promise of new ground being turned regarding the subject to justify holding a third conference. They would be pleased to assist anybody who feels they would like to undertake planning for a third meeting. They plan to edit a volume on Mormon language, mainly from papers given at the conferences, but contributors can still submit other materials for consideration.

Should CMSC Meet?

Several members of the Committee have suggested that the time may be near when some kind of face-to-face meeting of the membership should occur. An early April one-day session would be possible. Considering how few written communications are submitted for the newsletter, a meeting may not make much sense. Do we have anything to say to each other? Are any of you interested in attending? Your comments will be welcome, so that if plans are to be laid, it can be done promptly.

The next issue of the newsletter, which will complete the first year, will appear immediately after Christmas. Any meeting in the Spring ought to be at least scheduled for announcement in that issue.

Christiansen Report Availability

Newsletter 2 reported availability of a report done in 1959 by John R. Christiansen for the General Melchizedek Priesthood Committee, which included extensive data from a stratified sample of stakes. What also needs to be known is that the report falls into four parts, each of
