DISCUSSION: TOPIC: <u>Diversity with Mormonism</u>. Very little data is available on diversity within Mormonism. It is hoped that our evening can be spent in pooling our individual knowledge, and that from the discussion we may be able to put together a paper of some kind on the subject. Every one is asked to make some contribution, such as --

- --bring to the meeting any research information of which you are aware which makes comparisons such as Utah Mormons with non-Utah Mormons, or as the Ainsworth paper does on Southern and Western Mormons.
- --Observed differences, from your own experience or from whatever source available.
- --Hypotheses about intra-church differences, with related theory, etc.
- --Hypotheses or speculation about potential consequences of diversity within the church
- --Indications as to how intra-church differences have been handled in the past.

If you would be willing to make some type of short informal report on some aspect of the subject, this will be included. If you have data which could be sent in before the meeting, which could be duplicated for distribution, please do so. Some material is already on hand. Please send to Glenn Vernon. University of Utah. Salt Lake City, Utah 84112.

An effort will be made to make available to our membership the results of the meeting. This can he done through the newsletter or if the material seems to warrant it, some other publication source can be sought. If material can be sent in before the meeting that would be great. If you prefer, however, bring it with you. If you don't have any particular input, come and help us develop some ideas on the subject. It should be an exciting discussing.
